Interns may receive academic credit for their time, as long as it is pre-approved by the interested student's academic advisor and will fulfill their school's specific requirements. Interns are assigned a supervisor within the organization to help with scheduling, responsibilities, and projects, plus educational and skill-building opportunities.

About interning: Our work is hard – but it's an amazing, inclusive environment in which to learn. Interns gain Vermont Victim Crisis Worker Privilege, learn how to provide advocacy and support to survivors, answer our hotline, and experience what working at a small non-profit is really like.

About Steps: We recognize the intersection of the impacts of intimate partner violence with racism, transphobia, sexism, ableism, and all other forms of oppression. We celebrate diversity and are committed to creating an inclusive workplace for all. Survivors of domestic violence are strongly encouraged to apply, and lived experience is taken into consideration as a qualification along with work experience.
